Change is Here: Now Put Your Cell Phone DOWN

You cannot drive a mile down the road without seeing another driver on their cell phone. They might be talking to someone, texting, or even on social media. Due to the hazards and the number of injuries and deaths that distracted driving has caused, the Florida Legislature has FINALLY made some cell phone usage illegal while you're driving.

Since July 1, 2019, a person may not operate a motorized vehicle while manually typing or entering multiple characters into a wireless communication

device. Additionally, drivers are permitted to use their cellular devices while driving for any kind interpersonal of communication which includes texting, emailing, and instant messaging.

The only exceptions to the law will be if drivers are operating a n emergency vehicle, reporting a n emergency, criminal or suspicious activity

to law enforcement officers, receiving messages that are related to the operation or navigation of the motor vehicle, receiving safety-related information including emergency, traffic, or weather alerts, using a device navigation purposes, conducting communications that does not require the driver to enter multiple characters or read text messages, using a wireless communications device in a voice-operated mode such as a Bluetooth device, or operating a vehicle in autonomous mode. This law will also not apply to a driver whose vehicle is stationary.

When an officer pulls someone over they must notify a driver of their right to decline a search of their cellular device. Police officers are not permitted to access the device without a warrant, confiscate the device while waiting for a warrant, or obtain consent through coercion or improper methods. The law will, however, allow cellular phone records to be admissible in court if an accident occurs that causes a death or personal injury.

The consequences for not following the law will keep adding up. The first offense will be punishable by a \$30 fine, with a second offense costing \$60. Court costs and fees also would apply and points can be added to your license.

This law is intended to improve roadway safety and decrease the number of distracted drivers. The Legislature is also taking this law a step farther and

> drivers he required be completely hands free school crossing, a n d construction zones. This that drivers use their cell phone in these designated zones for any reason that requires them to hold their cellular phone.

The same exceptions from the

previous law will apply to the hands-free zones as long as drivers are using the cellular device in a hands-free manner while using the navigation and Bluetooth devices.

The intent of this legislation is to improve roadway safety in school and work zones for all vehicle operators, passengers, bicyclists, pedestrians, and other road users. It is the Legislature's intent to assist in reducing injuries, deaths, property damage, health care costs, and automobile insurance rates related to motor vehicle crashes.

In 2016 alone, Florida had nearly 50,000 accidents caused by distracted drivers resulting in 233 deaths. We must all reprogram ourselves to put the phone down when we are behind the wheel. It really

Your Vehicle, Your Insurance, Your Responsibility

I let my sister borrow my car to run to the store and she got into an accident. Now what? Many people believe that car insurance follows the person when really it primarily follows the vehicle.
